#### DUCKS UNLIMITED

Ducks Unlimited and partners were recently awarded \$25 million from the US Department of Agriculture through the Regional Conservation Partnership Program (RCPP).

DU and RCPP partners will work with South Dakota producers to restore over 25,000 acres of grassland over five years, emphasizing working lands and rotational grazing systems.

The goal is to incentivize a voluntary, partnership-driven approach to conservation on working agricultural lands by combining environmentally beneficial practices with new revenue streams for farmers and ranchers. RCPP partners include Natural Resources Conservation Service, South Dakota Soil Health Coalition, South Dakota Grassland Coalition, the U.S. Fish and Wildlife Service, South Dakota Department of Game, Fish & Parks, and Audubon Great Plains.

The partnership will be able to provide short-term land rental payments designed to offset financial offsets that accompany the grassland establishment period, which typically lasts 2-3 years for active grass plantings.

As a note, while the title of this project is similar to the the South Dakota Grasslands Initiative project focusing on partnership collaboration, this grant is separate work focusing on landowner support' At Growing Resilience, we have a team of scientists, journalists and social media professionals to provide multiple platforms (website, magazine feature stories and social media) to disseminate content in the form of video, audio (podcast and radio) and written material (blogs, feature stories) that highlight soil and rangeland heath and that encourage regenerative management.



A few projects that you might like to see are:

- We have just started our 'School the Professor' series of how farmers and ranchers and their observations are educating a professor (see Growing Resilience Social media outlets FB, Instagram and X)
- Our podcast with Gabe Brown was recently released and received good response we plan to release an interview with Rick and Liz Haney in the next few weeks. We're excited about uppcoming interviews with Tate Lanz and Laura Kahler on the Grasslands Roadmap and the SD Grasslands Initiative. - We are in the home stretch of our weekly Soil Health Challenge. The challenge consists of a quick multiple-choice question followed by a short (~1-minute video (of a rancher/farmer) that provides the answer to the question. From a poll (~100 people), it seems like this communication strategy has been more effective than newsletters, TV and radio spots or printed material. We collaborated with SDACD and SD Grassland Coalition with this activity and are (a little surprised) and pleased with the results.
- Based on the performance of this soil health challenge, we are developing a series of
  interactive activities that we hope we can offer to partners that would aim at increasing
  their profiles and educating their membership. We plan to prioritize grassroots
  organizations in SD that deal with livestock and ranching and hope to be reaching out to
  these organizations soon.

#### **NRCS**




Natural Resources Conservation Service (NRCS) is a federal agency within the United States Department of Agriculture. (We were formerly known as the Soil Conservation Service or SCS). NRCS provides service in every county in South Dakota. Offices are usually located in the county seat. We are located within the USDA Service Center (look for a green sign!) along side the Farm Service Agency (formerly the Agricultural Stabilization and Conservation Service or ASCS), and the local county conservation district.

NRCS offers technical and financial assistance for free to rural and urban agricultural producers. Our offices are staffed

with technical experts experienced in conservation planning on all land uses from grassland to forest to cropland.

We work one-on-one with land managers to determine what best management practices are needed for their unique operations. This



We provide financial incentives to help offset costs of installing those practices. With the recent passage of the Inflation Reduction Act (IRA), NRCS's financial assistance fund pool has been increased significantly. This allows our agency to further assist land managers in meeting their conservation goals. Visit your local NRCS office to learn more! ## SOUTH DAKOTA AG LAND TRUST

#### South Dakota Ag Land Trust Receives More than \$22 Million in Grants

South Dakota's Agricultural Land Trust (SDALT) has recently been awarded two separate grants totaling nearly \$18.5 million to protect vital grassland habitat in the Northern Great Plains while also strengthening working ranchland operations and communities. These are in addition to a \$4.2 million grant awarded a year ago to help conserve working lands in the Black Hills.

SDALT received nearly \$18.3 million from the Regional Conservation Partnership Program (RCPP), as part of USDA's Natural Resource Conservation Service investment in advancing partner-driven solutions to conservation on agricultural land. The RCPP grant will support the perpetual protection of 8,000 acres of working ranches around the periphery of the Black Hills with minimally restrictive conservation easements. The predominately native grasslands of these protected properties will contribute tangible deliverables to NRCS climate-smart mitigation goals related to soil carbon sequestration while retaining these ranches as working lands.

A separate grant of \$173,200 from the National Fish and Wildlife Foundation (NFWF), as part of their Northern Great Plains Program, will provide financial assistance for costs of easement transactions and further incentivize landowner easement and partner donations in South Dakota.

SDALT works on a voluntary basis with South Dakota farmers and ranchers to conserve South Dakota's agricultural heritage and working landscapes for the benefit of future generations. Founding organizations are the South Dakota Farm Bureau, South Dakota Grassland Coalition, South Dakota Cattlemen's Association, and South Dakota Association of Conservation Districts.

"We have found that interest in conservation easements in South Dakota is high, particularly in and around the Black Hills," said SDALT Executive Director Tony Leif. "Protecting working lands from residential and commercial development with

easements is an essential tool for those landowners in the path of development who want to retain their productive agricultural operations into the future."

#### South Dakota Soil Health Coalition offers education, resources

With changing seasons and farmers wrapping up harvest and weaning livestock, South Dakota Soil Health Coalition continues its efforts to improve healthy operations! January is quickly approaching and plans for our 2024 Soil Health Conference are moving forward. This large-scale event brings leading local, regional, and international soil health experts in grassland, cropland and forestland to

#### **Biologist Introduction & Public Lands Restoration Project**

I serve as a Farm Bill Biologist with Pheasants Forever operating in the Southeast of the state where I primarily cover Bon Homme, Charles Mix, Hutchinson, and Yankton counties. As Farm Bill Biologists we are based out of the USDA offices where were work alongside the NRCS on Farm Bill related programs such as CRP and EQIP. We serve as a primary point of contact regarding wildlife habitat implementation and enhancements while acting as a guide through the myriad of programs available to the landowner.





While I've been employed, I have attended various meetings and events that touch on different topics and areas that we could improve upon for the betterment of the landowner. At one of these meetings a common theme was that the public lands could benefit from additional management that is currently unable to be completed. Completing that management would create an opportunity for improved wildlife habitat across a shared resource.

The solution I came up with was to utilize our local Pheasants Forever Chapter. The Pheasants Forever Chapters are groups of local people that have a particular concern and desire to see wildlife and outdoor recreation remain a culturally significant staple of these lands. I recognized that these local groups are perfectly poised to fill this missing piece of the puzzle. This being the case, I put together a novel plan that involved the signing of Special Use Permits to allow the locals access to assist the Fish and Wildlife Services with managing these underserved areas. On top of that, I am pushing forward the idea to establish a living plan to serve as a guide to prevent Waterfowl Production Areas and other undermanaged public assets from degradation to maintain high quality wildlife habitat on the landscape.

This project idea serves to demonstrate, that with a little bit of collaborative effort we have the ability to positively impact habitat locally even if the land isn't necessarily owned by us. As this idea expands, we plan on tying in fundraising events through the local chapter, habitat management workshops, and additional education with youth. I can serve as the primary point of contact for any questions regarding this project and help with any other habitat related questions people may have.
